

### Bio-note (R.S. Derashri)

Ravi Shankar Derashri, a legal luminary, a profound scholar, a historian, a patron of art and culture, was born on 21 May 1903 at Banera in Rajasthan. He was educated at Ajmer, Agra, Allahabad and London. He obtained his B.Sc degree from Allahabad University in 1926 and L.L.B. degree from Agra University in 1931. He was called to Bar from Lincolns Inn, England in 1936. He was a Member of Royal Asiatic Society, London and a Member of Bhartiya Vidvat Parishad.

In his twenties and thirties, he helped Bharat Ratna Maharishi D.K. Karve, in collecting funds and securing membership for SNDT Womenos University, the first Womenos University in India. Another outstanding contribution was in the field of art and culture. He collected hundreds of paintings and thousands of manuscripts during his lifetime which were donated to Government Museums and Research Institutes.

In his early days he was in close association with revolutionaries like Kesari Singh Barhat and freedom fighters like Haribhau Upadhayay and Kanak Madhulkar.

He was also a historian and research scholar and interacted with all eminent historians of his time, prominent among them being Jadunath Sarkar, Gauri Shankar, Hirachand Ojha and others. His correspondence with these historians have been published in the form of books which themselves are a rich source of historical material and a goldmine for research scholars.

As an advisor to princely states, he carried out schemes for the welfare of the people. Micro-Financing was introduced through an institution called Jakhira. The cultivators were given loans at cheap rates. Also, a large number of educational institutions were established and students were given scholarships.

The services rendered by him to the nation is recorded in the books published by the Government of India and other government aided research institutions. He died on 12 March 1962.
